POLLING DISTRICTS AND PLACES REVIEW 2011

1. Purpose of Report

- 1.1 To obtain the approval of proposals for the amendment of polling districts and polling places following the latest statutory review.

2. Recommendations

- 2.1 That the electors of Aldham and Boxted be consulted on the suggestion that the provision of separate polling facilities in those villages should be discontinued.
- 2.2 That subject to the consideration of any objections that may be received and to a subsequent equality analysis relating to the proposals referred to above, the schedule of polling districts and places set out in Appendix 1 to this report be approved.

3. Financial Implications

- 3.1 The provision of an additional three separate polling stations, as recommended in Great Cornard, would involve additional expenditure of approximately £500 at contested elections, whilst ceasing to provide polling stations in Aldham and Boxted would save about £900. Potentially therefore, the proposed changes might result in an overall saving of around £400 at a fully contested election.

4. Risk Management

- 4.1 This report is most closely linked with the Council's Corporate / Significant Business Risk No. 4 - Capacity. Key risks are set out below:

5. Consultations

- 5.1 Consultations have been undertaken with the Returning Officer, the Member of Parliament, all Parish and Town Councils and Parish Meetings in the area, District and County Councillors, political parties and Optua, which provides a range of services for disabled people across Suffolk.

6. Equality Analysis

- 6.1 An Equality Analysis has been undertaken. The purpose of requiring that polling places be kept under review is to ensure that all electors continue to have such reasonable facilities for voting as are practicable in all the circumstances and that, in so far as is practicable, the polling places are accessible to those who are disabled. In carrying out the review the Council must have regard to the accessibility needs of disabled persons.

7. Shared Service / Partnership Implications

- 7.1 None

8. Key Information

- 8.1 The Representation of the People Act 1983 requires that the Council divide its area into polling districts and designate a polling place for each district. It must also keep the arrangements under review. The Electoral Administration Act 2006 changed the way that reviews are conducted. Most importantly, a full review has to be undertaken every four years.
- 8.2 The current review is the second carried out under these procedures and was conducted in two stages. In mid-July public notice was given of its commencement and a schedule of the existing polling districts and polling places was published. Some issues that had been identified since the last review were also highlighted at that time. These included comments from members of the public that –
- There was no need for a separate polling station to be provided in Boxted and, in a time of austerity, its provision should cease
 - The polling station at The Granary in Quay Lane, Sudbury is a long way for voters from the Cat's Lane/Lucas Road/Hillside Road area to walk
 - The St. Mary's School Nursery, which is used as a polling station for Hadleigh South, is difficult to access for an elderly person pushing a wheelchair.
- 8.3 It was also pointed out at that time that it had been suggested that it was inconvenient for some voters in the North ward of Great Cornard to make the journey to the Stevenson Centre (which is currently designated as the polling place for both the North and South wards) by car. In addition, at the 2011 elections and referendum it had been necessary to alter the arrangements for voters of the East End area of East Bergholt as The Grange Country Park had changed ownership between the date of booking the premises and polling day and, as a consequence, the General Stores building, which had been used as the polling station on the site, was not - and would not in the future be - available for that use.
- 8.4 The vast majority of observations received during the initial consultation period were from parish councils and ward councillors expressing satisfaction with the existing arrangements, but the following comments were also received –

- The Returning Officer indicated that –
 - a) In relation to the polling station for voters at **East End**, East Bergholt, the use of the Clubhouse was unsatisfactory since, although the premises were fully accessible and wholly adequate, the building is located a considerable walking distance down a track at the northern end of The Grange Country Park site. The majority of the 344 electors of East End live in the Broom Knoll area, which is roughly the same distance from the Methodist Church in Gravel Pit Lane in the neighbouring parish of Brantham, as it is from The Grange. However, the roads to the Methodist Church are better, East End Lane in particular being narrow and without a path on either side. On balance, it is recommended that the Methodist Church be used instead of The Grange, although it is recognised that this could provoke a call for additional polling facilities for voters in Brantham, particularly from those who actually live in Gravel Pit Lane and will have to pass the polling station on their way to vote at the Village Hall.
 - b) In relation to the polling station at **Boxted**, the village has had its own separate polling station for many years. There are 94 electors in Boxted, about a quarter of whom are registered to vote by post. At the last elections 35 electors voted at the polling station at The Studio, Street Farm Barn, which is not accessible for wheelchair users. The nearest alternative is approximately 1.5 miles away. It is suggested that the electors of Boxted be consulted on a proposal to cease providing a separate polling station in Boxted.
 - c) A similar situation exists in **Aldham** where a caravan is stationed for the use of 160 electors. 76 voters (47.5%) used the polling station at the most recent elections but it is not of the required standard in so far as its accessibility for voters with disabilities is concerned. The nearest alternative, fully accessible premises is the Elmsett and Aldham Village Hall, which is 1.5 miles away. The Council may wish to consider consulting electors on the removal of separate polling facilities in Aldham.
- Detailed comments were made by Councillors Riley and Grandon regarding the polling stations in **Hadleigh**, which were generally supportive of the current arrangements. Hadleigh Town Council had suggested possible alternative premises, including the Seminar Suite above Hadleigh Library, other rooms at the Town Hall complex and the Ansell Centre. The Returning Officer's view is that any premises used as a polling station should be on the ground floor while the availability of parking in or around the Town Hall would be a potential problem if electors from both Hadleigh North and Hadleigh South voted at the Town Hall or nearby. It was pointed out that, although the Nursery at St. Mary's School is relatively small, it has not experienced a problem with overcrowding. Moreover, it is fully accessible and benefits from very good parking facilities nearby. Work has recently started on a Hadleigh Community Facility adjacent to the Swimming Pool which is likely to afford another option for polling facilities in the immediate vicinity of the current polling station. Until such time as that building is operational, the Returning Officer supports the retention of the existing arrangements.

- Great Cornard Parish Council indicated that it would prefer there to be two separate polling stations in both the North and South wards of **Great Cornard** and suggested Pot Kiln School as a possible additional polling station for electors in the North ward, and the Wells Hall Old School and the new Rugby Club premises in Spicer Way for the South ward.
 - a) Both Pot Kiln School and Wells Hall Old School were used as polling stations prior to 2007 when the Parish Council had asked that all the polling stations for both the North and South wards be located at The Stevenson Centre. The facilities at both are adequate and access to the Pot Kiln School will be significantly improved when a new access from Poplar Road is constructed next year. The Returning Officer supports the proposed use of Pot Kiln School as a polling station to serve a polling district of the North ward of Great Cornard containing the area north of a line formed by Church Road, Pot Kiln Road and Raydon Way. This would place around 2,100 electors at the school with 1,300 remaining at The Stevenson Centre. There are no scheduled elections until November 2012 by which time the new access road to the school should have been completed.
 - b) In relation to the proposed polling places for the South ward, the Returning Officer supports the proposals but has pointed out that the only logical drawing of the boundaries for the polling district served by a polling station at the Rugby Club would mean that, currently, only 500 electors would vote there. This figure would increase as more properties in the immediate area were occupied. In order to implement the Parish Council's request, a new polling district would need to be created containing the roads and properties south of Head Lane west of the Great Cornard Upper School and stretching to the southern boundary of the ward with the civil parish of Little Cornard
- Sudbury Town Council commented on the voting facilities for electors of the **Sudbury South** ward and, in particular, those living in the existing "Quay" polling district (DE). The Town Council suggested that an additional polling station be provided "due to there not being a polling station between Cat's Lane and The Granary in Quay Lane". There are, however, already 3 polling stations in Sudbury South ward, which should be sufficient for the 3,500 electors, while the convenience for voters will depend upon the location of the polling station and the shape and size of the polling district that it serves. The Town Council suggested the Kingfisher Leisure Centre, Belle Vue House or the LEAP Centre in Cornard Road as possible additional polling stations to The Granary, which is at the south-western extremity of the existing "Quay" polling district. Investigations have since revealed that, following the commencement of work to create a children's soft play area, there is no available space at the Kingfisher Leisure Centre. Also, Belle Vue House suffers from access difficulties. The LEAP Centre, on the other hand, is a modern facility that has no such problems and the Returning Officer has suggested that it should replace The Granary as the designated polling place. Councillor Bennett responded to the consultation expressing reservations about the convenience of the LEAP Centre for residents of the town centre and it would be opportune also to re-draw the polling district boundaries to tackle that issue. It is suggested that those voters currently in the "Quay" polling district but who live in the area bounded by Quay Lane, the south side of Friars Street from Quay Lane to Station Road, the south side of Station

Road from Friars Street to Meadow Lane, the west side of Meadow Lane from Station Road to Bullocks Lane and eastwards along Bullocks Lane and the footpath across Friar's Meadow to the boundary with the civil parish of Great Cornard should be transferred to the "Bridge" polling district, the polling station for which is the Nursery at St. Gregory's School. A polling district containing around 700 electors would then be served by a polling station centrally located at the LEAP Centre in Cornard Road and 300 voters would be transferred to vote at St. Gregory's School. It would, however, also be necessary to re-name the remainder of the former "Quay" polling district and it is suggested that "Station" would be an appropriate title. The proposal is illustrated on the map at Appendix 2.

8.5 Optua declined to comment on particular arrangements but replied to the consultation on the review undertaken in 2007 in general terms. Those comments are likely to be equally relevant now –

- Polling stations should be located in buildings that are accessible. In choosing which buildings to hire...the owners should be able to satisfy the Council that their building is accessible
- If you are reducing the number of urban polling stations, those left will require commensurately better facilities as the throughput of disabled voters will be greater
- Venues should have either on-site car parking, including space for "blue badge" holders, or safe dropping off points where there is no parking.

8.6 In addition to those in the paragraph above, other general principles adopted for the review were, as far as possible, to ensure that –

- All electors have such reasonable facilities for voting in all the circumstances
- Every polling place is located in its own polling district
- No polling place is shared by two wards
- "Natural" boundaries should be used, e.g. the line of rivers, railways or the centre line of roads
- Polling places are logical, i.e. electors should not have to pass one polling station in order to get to their own

8.8 Stage Two of the proposals setting out the amended proposals in the light of the comments received was carried out during October involving the same consultees. The only new observation received at this stage concerned Boxted, where the Parish Meeting on 12 October resolved to agree with the suggestion that a separate polling station for Boxted be no longer provided and that residents of Boxted should in future use the facilities at the Boxted and Hartest Village Institute.

8.9 Before removing any facilities it would be appropriate to inform voters individually of any proposed changes. It is therefore recommended that the residents of Aldham and Boxted be consulted and that, subject to consideration of any objections that may be received to the proposals for Aldham and Boxted, the schedule of polling districts and polling places set out in the attached schedule (Appendix 1) be approved.
