**LICENSING ACT 2003 - HEARING REPORT (TEMPORARY EVENT NOTICES)
CONSIDERATION OF OBJECTION NOTICE ISSUED UNDER SECTION 104**

1. Purpose of Report

- 1.1 To report information to the Licensing Sub-Committee to enable consideration of an OBJECTION NOTICE given by the Environmental Health Officer under section 104 of the Licensing Act 2003, in respect of a Temporary Event Notice (TEN).
- 1.2 The Police and local Environmental Health authority have powers to object to a TEN where they are satisfied that allowing the premises to be used in accordance with the notice would undermine a licensing objective.

2. Recommendations

- 2.1 The Sub-Committee must, having regard to the section 104 objection notice (attached as Appendix B), determine whether or not to give a counter notice to the premises-user under section 105 of the Licensing Act 2003 to prevent the event from going ahead; and
- 2.2 If the Sub-Committee has decided under section 105 not to give a counter notice under that section, to determine whether it is appropriate for the promotion of the licensing objectives to impose one or more conditions on the standard temporary event notice - provided that such conditions are (a) also imposed on premises licence BPL0196 held for the same premises; and (b) are not inconsistent with the carrying out of the licensable activities under the temporary event notice.

The Sub-Committee is able to resolve these matters

3. Financial Implications

- 3.1 There is a statutory right of appeal to the magistrates' court for any party aggrieved by the decision taken by the Licensing Authority.

4. Risk Management

- 4.1 None, other than those that inherently apply to the Licensing Authority when carrying out its licensing functions. The four licensing objectives are prevention of crime and disorder, public safety, prevention of public nuisance and protection of children from harm.

5. Consultations

- 5.1 The notice has been given subject to the statutory consultation requirements with the Police and Environmental Health Department. There are no public advertising requirements for temporary event notices and 'other persons' (including local residents and businesses) are not entitled to raise representations for this type of licensing process.

6. Equality Analysis

- 6.1 There are no equality impacts arising directly from the matters contained within this report.

7. Shared Service / Partnership Implications

- 7.1 Not applicable.

8. Key Information

- 8.1 The Sub-Committee must consider the objection notice given by the Environmental Health Officer, and having regard to the objection notice give the premises user a counter notice under section 105 of the Licensing Act 2003 if it considers it appropriate for the promotion of a licensing objective to do so.
- 8.2 The four licensing objectives are:
- (a) The prevention of crime and disorder
 - (b) Public safety
 - (c) Prevention of public nuisance
 - (d) Protection of children from harm
- 8.3 Should the Sub-Committee determine not to issue a counter notice under section 105, and allow the event to go ahead, then it will need to make a further decision on whether it is appropriate to attach conditions under section 106A of the Licensing Act 2003.
- 8.4 Conditions may only be attached under this provision where the same premises are already licensed via a premises licence (or club premises certificate). The Licensing Authority may only apply those conditions from the linked premises licence which are consistent with the activities sought by the temporary event notice.
- 8.5 If the Licensing Authority imposes one or more conditions under section 106A then it will need to give the premises user a notice of the decision accompanied by a separate 'statement of conditions', in the prescribed format, setting out the conditions which apply to the TEN. This must be given no later than 24 hours before the commencement of the activities specified in the TEN. Each party to the hearing must also be given these documents.

**LICENSING ACT 2003 - TEMPORARY EVENT NOTICE RECEIVED 22 AUGUST 2012
'BEER FEST', 07-09 SEPTEMBER 2012
ANCHOR INN, NAYLAND, 26 COURT STREET, NAYLAND, COLCHESTER CO6 4JL**

In accordance with the requirements of Section 104 of the Licensing Act 2003, I write to notify you that I have submitted an objection to your application for a Temporary Event Notice (TEN) for the proposed event listed above.

I am satisfied that allowing the premises to be used in accordance with the TEN, would impact on promotion of the licensing objectives, specifically the prevention of public nuisance.

The application proposes a 3 day/evening event with regulated entertainment. The location is specified as being "At the bottom of the pub's garden". Regulated entertainment covers a wide remit of licensable activities including the playing of amplified live or recorded music.

The premises is closely surrounded by residential properties on three sides and Babergh District Council's Environmental Protection service has received complaints from several residents over a number of years regarding the playing of amplified music at the premises. These relate to:

- May 2000: A lunchtime BBQ on a Bank Holiday Monday with amplified music;
- August 2000: Noise from amplified music played at BBQs on Bank Holiday Mondays;
- June 2005: Live music played in car park from mid-afternoon until mid-evening on a Sunday;
- September 2005: Live music being played outside in grounds of pub; and
- June 2011: Loud music played in pub for last 3 nights until gone 1am.

A Statutory Noise Nuisance was witnessed on the first two of these occasions by an Environmental Health Officer. With regard to the last occasion, a Simple Caution was issued to the previous DPS for a breach of the Premises Licence, namely the playing of live music when this was not licensed.

Given the unspecified nature of the regulated entertainment, I must assume that amplified music could be played if the TENS were to be granted. Given the:

- close proximity of neighbouring properties;

- that the application proposes to use an outdoor location;
- the long duration and late finish times proposed on three consecutive nights over a weekend;
and
- the history of noise complaints;

I am of the opinion that the application would give rise to a public nuisance from noise. This would cover not only music noise, but also noise from people attending the event and from traffic arriving/departing the premises late at night.
