LICENSING ACT 2003 – HEARING TO DETERMINE AN APPLICATION MADE FOR THE GRANT OF A NEW PREMISES LICENCE

1. Purpose of Report

- 1.1 To report information to the Sub-Committee to enable the determination of an application made for the GRANT of a NEW premises licence for Morrisons (supermarket) at Calais Street, Hadleigh, IPSWICH IP7 6LB.

2. Recommendations

- 2.1 The Sub-Committee must, having regard to the representations made, take such of the steps below (if any) as it considers appropriate for the promotion of the licensing objectives:

- to GRANT the licence subject to conditions which are consistent with the operating schedule accompanying the application - modified to such extent as the authority considers appropriate for promotion of the licensing objectives - and subject to any mandatory condition(s) which must be included in the licence;
- to EXCLUDE from the scope of the licence any of the licensable activities to which the application relates;
- to REFUSE to specify a person in the licence as premises supervisor; or
- to REJECT the application.

For these purposes conditions of the licence are *modified* if any of them are altered or omitted or any new condition is added.

The Sub-Committee is able to determine this application.

3. Financial Implications

- 3.1 There is a statutory right of appeal to the magistrates' court for any party aggrieved by the decision taken by the Licensing Authority.

4. Risk Management

- 4.1 None, other than those that inherently apply to the Licensing Authority when carrying out its licensing functions. The four licensing objectives are prevention of crime and disorder, public safety, prevention of public nuisance and protection of children from harm.

5. Consultations

- 5.1 The application made has been subject to the statutory consultation period as prescribed by regulation. The notices required by regulation have been on display at the premises and published (East Anglian Daily Times, 1 August 2012 edition).

6. Equality Analysis

- 6.1 There are no equality impacts arising directly from the matters contained within this report.

7. Shared Service / Partnership Implications

- 7.1 Not applicable.

8. Key Information

- 8.1 The hearing is to determine an application for the GRANT of a NEW premises licence (application number 007903) made under section 17 of the Licensing Act 2003. A copy of the application is attached as Appendix A and the large scale licence plan submitted will be on display at the hearing.

- 8.2 The application has been submitted by:

WM Morrison Supermarkets PLC (registered company number 00358949)

For proposed licensed premises:

Morrison's, Calais Street, Hadleigh, IPSWICH IP7 6LB (this is part of the 'QD Stores' site, who still retain their own premises licence for part of the site)

The designated premises supervisor DPS is:

Nakesha Murrain (a personal licence holder with Leeds City Council)

- 8.3 Generally, the application seeks the supply of alcohol activity (for consumption OFF the premises only) 6.00am to midnight Monday to Sunday as part of its retail supermarket operation.
- 8.4 The operating schedule steps proposed by the applicant to promote the licensing objectives are listed at Part P of the application form attached as Appendix A.
- 8.5 A hearing is necessary to determine the application (number 007903) following receipt of a relevant representation which has not been withdrawn. The Licensing Authority must carry out its functions under the Act with a view to promoting the licensing objectives, which are:
- (a) the prevention of crime and disorder;
 - (b) public safety;
 - (c) the prevention of public nuisance; and
 - (d) the protection of children from harm
- 8.6 In carrying out its licensing functions, the Licensing Authority must have regard to its 'Statement of Licensing Policy' published under section 5 of the Act, and any guidance issued by the Secretary of State under section 182.

8.7 Where revisions are made to the legislation or guidance issued by the Secretary of State, there may be a period of time when the local Statement of Licensing Policy is inconsistent with these revisions. In these circumstances, the Licensing Authority will have regard, and give appropriate weight, to the relevant changes, guidance and its own Statement of Licensing Policy.

8.8 The Sub-Committee will also be aware of Human Rights Act 1998 considerations - specifically Article 6 for the applicant and Articles 8 and 1 of Protocol 1 for those raising representations - when determining applications for the grant of a new licence.

9. Representations

9.1 A representation has been received from the Environmental Health Officer. His submissions are attached as Appendix B to this report.

9.2 There have been no representations made by 'other persons' (which includes local residents and businesses).

I would like to make the following representation on this application in relation to the licensing objective of preventing public nuisance.

The licence for the previous owners (QD Stores Ltd) restricts the sale by retail of alcohol for consumption OFF the premises to:

- Monday to Saturday 08:00hrs until 23:00hrs
- Sunday (other than Christmas Day) 10:00hrs until 22:30hrs
- Christmas Day 12:00hrs until 15:00hrs and 19:00hrs until 22:30hrs
- Good Friday 08:00hrs until 22:30hrs

I am therefore concerned that if granted, the Premises Licence would result in the generation of increased noise above the current "baseline" associated with:

- (a) increased vehicular traffic to and from the site;
- (b) increased noise in the car park;
- (c) since the application would allow an increase in trading for the store, there would presumably be an associated increase in the number of delivery vehicles bringing additional goods to the store; and
- (d) with an increase in delivery vehicles there would presumably be a concurrent increase in noise from unloading operations e.g. fork lift trucks, reversing alarms, movement of roll cages, noise from workers etc.

In my opinion, the following hours would be more appropriate in this location so as to prevent public nuisance from noise.

1. Section M (Supply of alcohol)

Monday to Saturday 07:00hrs until 23:00hrs
Sundays, Christmas Day and Good Friday 09:00hrs until 22:30hrs

2. Section O (Hours premises are open to the public)

Monday to Saturday 07:00hrs until 23:00hrs
Monday to Saturday 07:00hrs until 23:00hrs
Sundays, Christmas Day and Good Friday 09:00hrs until 22:30hrs

I have written to the Applicant to try to reach agreement on my proposed amendments to their application, but I have not received a response to-date. I will advise you if I do.
