UPDATE ON COMPLIANCE WITH THE LOCALISM ACT 2011

1. Purpose of Report

1.1 To update Members on the measures taken to comply with the requirements within Chapter 7 of the Localism Act and to identify any further actions required.

2. Recommendations

- 2.2 That the Committee identifies any further steps required to be taken.

8. Key Information

- 8.1 This report identifies the actions outstanding to secure full compliance with Chapter 7 of the Localism Act 2011 by (i) the Councils, (ii) parish/town councils and (iii) councillors.
- 8.2 Chapter 7 came into effect on 1 July 2012 and introduced a new standards regime for all councils. A new Local Code of Conduct has been adopted across Suffolk, a new complaints system has been put in place and a pool of 'independent persons' has been appointed. These arrangements were made at the outset and appear to be working effectively. There are however still some outstanding actions as follows:-

District Councillor Register of Interests

8.2.1 Across both Councils all but two Babergh councillors have completed updated Register of Interests forms. Reminders have been issued to the councillors, the latest on 18 October 2013. The Register should have been completed by 29 July 2012.

Parish Council Register of Interests

- 8.2.2 Likewise, all town/parish councillors were required to complete new Register of Interests forms which are held on a public register by the district council. Action taken since the last committee meeting has resulted in a further increase in compliance. As at 22 October 2013, 91% (previously 85%) of parish councillors within the Babergh district and 89% (previously 75%) of those within the Mid Suffolk district have submitted completed forms.
- 8.2.3 However, there are 4 out of 67 (previously 7) parish/town councils in Babergh and 7 out of 95 (previously 19) parish councils in Mid Suffolk from whom no Registers have been received, as identified in the Table below. The latest reminder was sent out by the Monitoring Officer on the 18 October to the clerks of those councils. The Suffolk Association of Local Councils has also previously issued reminders.

- 8.2.4 The following action has been taken since the last meeting of this committee:

 - Letters to Parish Clerks;
 - Letters to District Councillors:
 - Further advice given on declaration and registration of interests:
 - o guidance issued on action to be taken
 - o item included in the October 2013 Parish Councils' Newsletter and;
 - An audit commenced to ensure the data is up-to-date and accurate following the recent attempts to increase compliance

Publication of Registers

- 8.2.5 All of the completed district council Register of Interests forms have been placed on the Councils' respective websites as required by the Localism Act. The Babergh parish/town council registers have been placed on its website although this has meant individually checking and scanning hundreds of forms.
- 8.2.6 It has not yet been possible to overcome the technical ICT problems in hosting the Mid Suffolk parish/town registers. An alternative solution has been identified which should be in place within the next few months. In the future all Registers in both authorities will be submitted electronically. To enable this to happen, starting in November further training will be provided to the technical staff, and then to clerks and Committee Services at a later date.
