66 DECLARATION OF INTERESTS

Mr A C Bavington and Ms J A Jenkins both declared non-pecuniary interests in respect of Minute No. 70 below ([Paper M159](#)) through their involvement as the Council's representative (or substitute) on the Shared Revenues Partnership Joint Committee, but indicated that they were able to speak and vote on the matter.

Mr A J Hinton declared a non-pecuniary interest in respect of Minute No 69(c) ([Paper M132](#)) in his capacity as the Council's representative on the Ipswich Area Policy Board and in Minute No. 69(d) (Paper M148) by virtue of being a member of East Bergholt Parish Council. He indicated that he was able to speak and vote on both items.

The Chairman referred to [Paper M157](#) outlining recent events attended by the Chairman and Vice-Chairman of the Council. He had also attended the funeral of Mrs Arthey, one of the earliest Members of Babergh District Council.

69 RECOMMENDATIONS AND REPORTS FROM COMMITTEES

(a) Draft Treasury Management Strategy (Overview and Scrutiny Committee Minute No. 45 and Strategy Committee 14 February 2013)

Ms J A Jenkins, Chairman of the Strategy Committee, introduced the Committee's recommendations. Members noted that the position regarding Santander UK plc, as referred to in (3) below, would be re-visited as part of the mid-year reporting process. Consideration would also be given later in the year to the possible approval of investment with Singaporean Banks meeting the relevant criteria, and subject to the advice of the Council's treasury advisers.

RESOLVED

(1) That the key factors and information affecting treasury management activities set out in Appendix A to [Paper M138](#) (as amended by [Paper M138A](#)) be noted.

(2) That the following be approved:

(a) The Treasury Management Policy Statement and the Policy for Managing the HRA Debt set out in Appendix B to Paper M138

(b) The Draft Treasury Management Strategy for 2013/14, including the Annual Investment Strategy, as set out in Appendix C to Paper M138 (as amended by Paper M138A).

- (c) **The Draft Prudential Indicators and Limits for 2012/13 (revised) to 2015/16 set out in Appendix D to Paper M138 (as amended by Paper M138A).**
- (3) **That the current position regarding Santander UK plc not being included on the counterparty list be confirmed.**
- (b) Housing Revenue Account – (a) Draft HRA Budget 2013/14, (b) Proposed Rents and Charges 2013/14 (c) Review and update – HRA Business Plan 2013/14 (Strategy Committee Minute No. 101)

Ms J A Jenkins, Chairman of the Strategy Committee introduced and proposed the Committee's recommendations, which were then seconded. Members had before them [Paper M131A](#) setting out amendments to [Paper M131](#), which had been incorporated into the recommendations before the Council. The Corporate Managers for the Housing Revenues Account, and Financial Services, responded to questions from Members.

During the course of the discussion, an amendment was moved and seconded that rent increases be limited to the September 2012 RPI. The Chief Executive referred to the requirement to set a balanced budget and the role of Barry Hunter, the Section 151 Officer, in advising Members on the effect on the Budget of the proposed amendment. At this point, the meeting adjourned between 10.10 a.m. and 10.25 a.m. to enable Mr Hunter to calculate the effect of using the September RPI instead of the figure of 5.17% recommended by the Strategy Committee.

When the meeting resumed, Members were advised that applying the September RPI of 2.6% would result in a budget shortfall in 2013/14 of £350,000, rising to £1.75m over a 5-year period, with other 'knock-on' effects, and an increase in future years of 7-8% to make up the shortfall. He also referred to the effect on our debt repayment strategy and rent divergence policy. Members noted that reserves could not be used to meet the shortfall as these were reducing to a minimum of £1m in accordance with the Council's approved Reserves Policy. After further discussion the amendment was lost on being put to the vote. The Strategy Committee recommendations, as amended in accordance with Paper M131A, were carried.

RESOLVED

- (1) **That the Draft HRA 2013/14 Budget as presented in section 8.7 of Paper M131 (as amended by the table set out in Paper M131A) be approved.**
- (2) **That the Draft HRA 2013/17 Capital Programme as contained in Appendix (a) of Paper M131 be approved.**
- (3) **That changes to Council rents and charges for 2013/14 be approved as follows:-**
- **Housing Rents are increased by 5.17%**

- **Garage rents are increased by 5.17%**
- **Sheltered communal service charges are increased by 5%**
- **Sheltered utility charges are decreased by 2.88%.**

- (4) **That the creation of ‘new build/acquisitions pot’ within the Capital Programme as referred to in Paragraph 8.11 of Paper M131 be noted.**
- (5) **That the allocation of Right to Buy receipts between the HRA and General Fund as referred to in Paragraph 8.13 of Paper M131 be noted.**
- (6) **That the review of the HRA Business Plan as referred to in Paragraph 8.30 and the revised Appendix (b) attached to Paper M131A be noted.**
- (7) **That the proposals for development of HRA strategic priorities and use of surplus revenues as referred to in Paragraphs 8.33 to 8.36 of Paper M131 be noted.**
- (8) **That, in paragraph 8.23 of Paper M131, the replacement of the figure ‘£1.5m’ by ‘£1m’ as referred to in Paper M131A be noted.**

(c) Ipswich Area Policy Board – Approval of Revised Terms of Reference (Strategy Committee Minute No. 102)

Ms J A Jenkins, Chairman of the Strategy Committee in introducing the recommendation for a substitute member on the Board, referred to the Strategy Committee’s decision to approve its revised terms of reference. Mrs Carpendale was proposed and seconded for this position.

RESOLVED

- (1) **That a substitute Member be appointed in accordance with the revised Terms of Reference attached as Appendix A to [Paper M132](#).**
- (2) **That Mrs S Carpendale be appointed as the substitute member on the Ipswich Area Policy Board for the remainder of the current term of office.**

(d) Additions to the Affordable Homes Programme – Proposed Affordable Housing Schemes – Fiddlers Lane, East Bergholt and Lady Lane, Hadleigh (Strategy Committee 14 February 2013)

Ms J A Jenkins, Chairman of the Strategy Committee, introduced the Committee’s recommendations for the inclusion of two schemes in the Council’s Affordable Housing Programme.

An amendment was proposed and seconded for the provision of 2 x two bedroomed properties in place of the 1 x 4 bed roomed property proposed. The amendment was lost on being put to the vote. The Corporate Manager – Strategic Housing responded to questions from Members and agreed to supply, outside the meeting, information relating to the current arrangements for allocating Council properties and meeting the local connection criteria.

RESOLVED

That the two schemes on Babergh owned land as shown in Appendices 1 and 2 to [Paper M148](#) be approved in principle and be included within the Council's Affordable Housing programme, it being noted that all schemes require full consultation with Local Members, together with the Parishes, stakeholders, tenants and others as necessary.

- **4 x two-bedroom bungalows for affordable rent at land off Fiddlers Lane, East Bergholt.**
- **1 x four-bedroom dwelling for affordable rent at land adjacent to 4 Lady Lane, Hadleigh.**

- (e) Norfolk and Suffolk Gypsy and Traveller Strategy (2012 – 2014) (Strategy Committee 14 February 2013)

Ms J A Jenkins, Chairman of Strategy Committee, introduced the Committee's recommendations.

An amendment to note, rather than approve, the Strategy was proposed and seconded. The Corporate Manager – Strategic Housing explained in more detail the role which the Strategy would fulfil, in giving officers a framework within which to operate, following which the amendment was withdrawn without being put to the vote.

RESOLVED

- (1) **That the new Norfolk and Suffolk Gypsy and Traveller Strategy for 2012 – 2014 as attached at Appendix 1 to [Paper M150](#) with the amendments as detailed in section 5.2 of the report be approved.**
- (2) **That the annual monitoring of the Strategy and associated Action Plan be undertaken by the Housing Panel, any decisions or actions to be referred to Strategy Committee.**

- (f) Suffolk Health and Wellbeing Strategy: A Ten Year Strategy Early Priorities for Review 2015

Ms J A Jenkins, Chairman of Strategy Committee, introduced the Committee's recommendations, following which she asked Dr M F M Bamford, the Council's representative on the Suffolk Health and Wellbeing Board to explain some of the background to this item.

RESOLVED

- (1) That the Joint Health and Wellbeing Strategy developed by Suffolk's Health and Wellbeing Board attached as Appendix A to [Paper M152](#) be adopted as part of the Babergh policy framework.**
- (2) That Babergh will contribute to the implementation of the Joint Health and Wellbeing Strategy through its service delivery mechanisms and through proactive membership of the Suffolk Health and Wellbeing Board which has the statutory duty to produce the Strategy and Joint Strategic Needs Assessment.**

70 FINANCIAL OUTLOOK AND GENERAL FUND REVENUE BUDGET 2013/14

Ms J A Jenkins, Chairman of the Strategy Committee, introduced the Committee's recommendations which were included in [Paper M159](#), as amended by replacement pages 15, 32 - 33 and 35 – 37 which were circulated to Members prior to the commencement of the meeting. She referred to the continuing financial challenges facing the Council to produce significant year-on-year savings in addition to those already achieved and those which are being delivered as a result of the integration of staffing structures and service delivery with Mid Suffolk District Council.

Ms Jenkins also referred to the constructive lobbying by Councils and groups such as SPARSE to put the case of the rural authorities bearing the brunt of Government funding cuts. She reported that, as a result, a one-off 'rural efficiency grant' has been introduced, which recognises to some extent the funding needs of rural councils. She also referred to the opportunity to bid for funds from the new Transition Challenge Award, and reminded Members that 2013/14 will be very much a transitional year for Babergh with the Council's Budget being realigned and resources reallocated to meet its strategic priorities.

The Corporate Manager – Financial Services then highlighted some key aspects and responded to questions from Members. He also informed Members of the current position regarding the final precept figures which were still awaited for the parishes of Layham, Raydon and Alpheton, and reported the Wattisham figures which had now been confirmed. Members were aware from the additional paper circulated at the meeting that they would be asked to agree the standard Council Tax resolutions subject to authorising the Corporate Manager – Financial Services to adjust the relevant precept levels to reflect the finalised figures as confirmed by the parishes.

RESOLVED

- (1) That the information contained in Paper M159 on the financial outlook and the indicative further additional significant reductions in Government funding in 2014/15 and beyond be noted.**
- (2) That the General Fund Budget for 2013/14 of £8,865k as set out in Section 8.17 - 8.22 of Paper M159 based on:**
 - (a) A District Council Tax precept of £4,367k reflecting a freeze in Council Tax**

- (b) Subject to more detailed consideration by Members, using the New Homes Bonus as indicated in the report (and as also summarised in Appendix E)**
 - (c) The cost pressures, savings and income referred to in the report be approved.**
- (3) That it be noted that the Budget continues to include the net cost of car parking in the District of around £180k per annum and that a clear proposition to remove or reduce this cost in relation to future Budgets remains under review, with a view to this being resolved in 2013 and in time for setting the 2014/15 Budget.**
- (4) That, where expenditure is included within the approved budget, the Section 151 Officer be empowered to:-**
 - Vary the timing of revenue and capital payments from the current financial year to 2013/14 or vice-versa in accordance with Financial Regulations and Council resolutions.**
 - Vary the method of financing capital schemes, if satisfied that it is in the financial interest of the Council to do so.**
- (5) That the Corporate Manager – Financial Services be authorised to make any necessary minor amendments to the Policy and Budget Framework and 2013/14 Budget information before it is published.**
- (6) That the proposed General Fund Capital Programme for 2013/14 as shown in Appendix C to Paper M159 be approved.**
- (7) That the statement from the Section 151 Officer under Section 25 of the Local Government Act 2003 covering the Robustness of Estimates and Adequacy of Reserves set out in Appendix H to Paper M159 be approved.**
- (8) That the following be approved in relation to War Widows Benefits Disregards:**
 - (a) That the existing housing benefit and council tax benefit modified schemes detailed in Appendix F to Paper M159 be amended to confirm the existing full disregard of War Widows and War Disabled Pensions (which includes Guaranteed Income Payments from the Armed Forces Compensation Scheme), above the statutory £10 per week disregard, as income in the assessment of housing benefit; That The Babergh Council Tax Reduction Scheme shall contain provisions to disregard any War Widows or War Disabled Pension (which includes Guaranteed Income Payments from the Armed Forces Compensation Scheme) as income in the assessment of any council tax reduction as detailed in Appendix F to Paper M159 from 1 April 2013.**
- (9) That the prescribed wording on empty homes discounts and premiums contained in Appendix F to Paper M159 be noted and approved.**

- (10) That it be noted that the Council is aiming to pass on 100% of the discretionary grant relating to the Council Tax Reduction Scheme to Town and Parish Councils.
- (11) That the estimated Business Rates Income for 2013/14 as per the NNDR 1 return shown in Appendix G to Paper M159 be noted.
- (12) That the 2013/14 transfers to and from reserves shown in Appendix D to Paper M159 be noted.
- (13) That the minimum safe contingency level of unearmarked reserves of £1.2m be approved.
- (14) That it be noted that it is a requirement for the billing authority to calculate a council tax requirement for the year as opposed to its budget requirement.
- (15) That it be noted that the Council, as delegated to the Section 151 Officer, calculated the taxbase:
- (a) for the whole Council area as 30,353.35 and,
- (b) for dwellings in those parts of its area to which a Parish precept relates as in Appendix K to Paper M159.
- (16) That the council tax requirement for the Council's own purposes for 2013/14 (excluding Parish precepts) is £4,366,630. The Council's basic amount of Council Tax for 2013/14 is not excessive in accordance with principles approved under Section 52ZX of the Local Government Finance Act 1992 (inserted by Schedule 5 to the Localism Act 2011).
- (17) That the following amounts be calculated for the year 2013/14 in accordance with Sections 31 to 36 of the Act:

(a)	£54,742,032	Being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(2) of the Act taking into account all precepts issued to it by Parish Councils (gross expenditure)
(b)	£48,135,220	Being the aggregate of the amounts which the Council estimates for items set out in Section 31(A)(3) of the Act (gross income)
(c)	£ 6,606,812	Being the amount by which the aggregate at 17(a) above exceeds the aggregate at 17(b) above, calculated by the Council, in accordance with Section 31A(4) of the Act, as its council tax requirement for the year. (Item R in the formula in Section 31A(4) of the Act) (net expenditure)
(d)	£217.66	Being the amount at 17(c) above (item R) all divided by item T (15(a) above), calculated by the Council, in accordance with Section 31B(1) of the Act, as the basic amount of its council tax for the year (including Parish precepts) (average council tax)
(e)	£2,240,182	Being the aggregate amount of all special items (Parish precepts) referred to in Section 34(1) of the Act as set out on pages 10 and 11 of these Minutes.

(f)	£143.86	Being the amount at 17(d) above less the result given by dividing the amount at 17(e) above by item T (15(a) above) calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its council tax for the year for dwellings in those parts of its area to which no Parish precept relates (basic council tax)

- (19) That the Council in accordance with Sections 30 and 36 of the Local Government Finance Act 1992, hereby sets the aggregate amounts shown in the table below and on pages 12, 13 and 14 of these Minutes the amounts of council tax for 2013/14 for each part of its area and for each of the categories of dwellings.
- (20) That it be noted that Suffolk County Council and the Police and Crime Commissioner have issued precepts to the Council in accordance with Section 40 of the Local Government Finance Act 1992 for each category of dwellings in the Babergh District Council's area as indicated in the table below.
